The undersigned, Andrew M. Kolstee, residing at 35 Fairfield Avenue, Jamestown, New York 14701, who is a duly registered voter in the State of New York, and having filed a general objection to the independent nominating petition filed on or about May 31, 2022 in the office of the New York State Board of Elections purporting to nominate:

Hamilton Parkway, 2nd, Brooklyn, NY 11288, Michael Henry, Independence Party candidate for Attorney General, State of New York, residing at 27-35 21 Street 8C, Astoria, NY 11102, Joe Pinion, Independence Party candidate for U.S. Senator, State of New York, residing at 276 St. Johns Ave., Yonkers, NY 10704 as candidates in the general election to be held on November 8, 2022,



and whose candidates contact person is Eric Amidon, residing at 16 Cornwallis Road, East Setauket, NY 11733


The undersigned alleges that the said nominating petition is insufficient, void, and not in accordance with the provisions of the Election Law of the State of New York. Specifications of the grounds of objections of the undersigned to said petition are as follows:

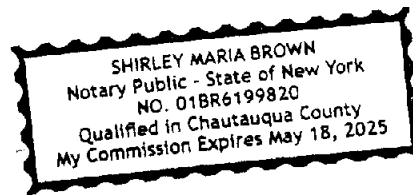
Pursuant to New York State Election Law, candidates for statewide office are required to submit no fewer than 45,000 valid signatures. The petition naming the above candidates contains fewer than 45,000 valid signatures. Specifically, the petition contains 52,287 signatures. Of these, 11,198 are invalid due to the fact that they are duplicate pages in the form of photocopies (see Appendix A). This brings the total number of valid signatures to 41,089. The individual objections to each of these can also be found in Appendix C. Of these remaining signatures, 4,309 signatures are invalid due to various reasons (see Appendix C). This brings the total number of valid signatures to no more than 36,780 signatures. Additionally, the petition does not meet the criteria for having more than 500 valid signatures in one-half of New York's 26 Congressional Districts (see Appendix B). Therefore, this petition is insufficient, void, and not in accordance with the provisions of the Election Law of the State of New York.

CONGRESSIONAL DISTRICTS

We object that the filing by Zeldin et al. does not meet the statutory requirement of 500 signatures in at least half (13) of New York's 26 congressional districts.

The filing's schedule claims 500 signatures or more in the following specific 15 Congressional Districts: 1,2,3,4,6,11,12,19,20,21,22,23,24,25, and 26. However, the numbers of signatures in 3 districts (6,11, and 12) do not actually reach 500. Without these 3 Congressional Districts, the statutory requirement of 13 Congressional Districts is not met.

The details are enumerated below, sheet by sheet. For each of districts 6, 11, and 12, we tabulate actual numbers of signatures that are (possibly) valid, for each of the Volume and Sheet numbers listed in the Schedule provided in the filing.

When a sheet with a particular number was not actually present in the filing, that is designated by NF, and the tally counts as 0 for that sheet.
