A hearing has been scheduled to review the objections and the staff worksheets on Monday, July 11, 2022, at 10:00 a.m.


You, or a representative, may attend in person or remotely utilizing the SBOE's WebEx system (link below). Personal or remote appearance by the parties involved in the action is not required.
